Sub:- Proposal for diversion of 1.973 ha forest land for construction of Re-rolling Plant for manufacturing of TMT bars/rounds ingots/billets of 30000 tons for annum capacity by M/s. Karma Re-rollers Pvt. Ltd, Kapursingh, Pihura.

Ref:- Memo No.3019 dated 10.01.2020 of Principal Chief Conservator of Forests(Forest Diversion & Nodal Officer, FC Act) and your memo No.3144 dated 23.07.2020.

On verification of the compliance submitted vide your memo under reference, the following discrepancies have been noticed.

1. As per observation in Point No. vii of the Principal Chief Conservator of Forests (Forest Diversion & Nodal Officer, FC Act), you have reflected 1.26 ha of non-forest land involved in the project as per joint verification on 08.07.2020, but in your site inspection report Col No. 8, it has been mentioned as 1.284 ha of non-forest land although you have reported in your compliance report that 1.26 ha of non-forest land has been reflected in the site inspection report. Besides the above, the purpose wise break-up of the total land shown in the site inspection report need to be verified and rectified as 3.240 ha instead of 3.257 ha. as per land use plan enclosed under page-62 of the Proposal.
2. In Part-I Col No.2 Purpose wise break-up of the total land, it has been mentioned 1.284 ha of non-forest land instead of 1.26 ha as per joint verification report on 08.07.2020 which needs to be rectified and mentioned correctly.
3. The CA scheme has been prepared at the wage rate of Rs.298/- per man-day. In the mean-time the wage rate has been revised to Rs.303.40 as per letter No.4864 dated 22.07.2020 of Labour Commissioner, Odisha, Bhubaneswar. Hence the scheme should be prepared as per revised wage rate and the financial out lay of the scheme should be shown in proper column accordingly.
4. The Land schedule of forest and non-forest land needs to be signed by DFO.

In view of the above, the Forest Diversion Proposal received vide your memo under reference is returned herewith in **5 sets** for necessary compliance and resubmission at the earliest.
