Sir,

Kindly refer to letter no. F-5-07/2020/10-2 dated 01.05.2024 of the Government of Chhattisgarh the online proposal registration no. FP/CG/Approach/32947/2018 (PARIVESH 1.0) on the above subject seeking prior approval of the Central Government under Section- 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. After the examination of the proposal in the Regional Office, MoEF&CC, following observations is noted:

- i. The proposed road is already in usage by the UA to approach mining site, hence, it is not clear whether the said road is under usage with the approval of the competent authority under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 or otherwise. The same may needs to be clarified by the State Government.
- ii. The proposed activities are ancillary activities of the mining proposal, hence reason for not including these components while submitting mining proposal needs to be clarified by the State Government and justification for submission of the instant proposal needs to be provided;
- iii. The State Government may submit a detailed report along with the condition's wise compliance report for the approval granted for mining project and detailed report on violation of Adhiniyam, if any.

In view of the above, I am directed to request the State Government to furnish above information/documents, to this Office at the earliest for further consideration of the subject proposal.

This issues with the approval of DDGF (Central), Regional Office, MoEF & CC, Nagpur.
