Sir,

In above subject it is to apprise your goods self that the initial examination of the FC Proposal no.FP/JH/TRANS/32955/2018 at IRO level revealed that numerous incorrect entries in the online application forms has been done. Even the area calculated from the upload kml file is only 4 ha whereas the proposal is for diversion of 163.5868 ha forest area. Similar discrepancies are present in various other parts of the online application too including proposed CA area.

It is therefore requested that user agency may kindly be asked to reexamine the application meticulously and correct them before forwarding. Concerned Forest Offices also may be requested to analyze the application adequately before accepting & further forwarding.

Accordingly, the proposal is hereby being returned along with the request made above.
