

Sub:- Proposal for diversion of 3.36 ha Forest land under section-2 of the Forest (Conservation) Act, 1980 for four lanning of Pune-Solapur section of NH-9 in Km 144/400 to Km 249/000 at Village Pakhani, Chikhali, Hivare, Dist. Solapur in the State of Maharashtra (FP/MH/Road/42876/2019).

Ref:- Your office letter No. A/Desk-4/4(2)/Land/FCA-373/2022-23/141, Dated 18/07/2022.

The Chief Conservator of Forests (T), Pune vide letter dated 18/07/2022 has submitted proposal for diversion of 3.36 ha Forest land under section-2 of the Forest (Conservation) Act, 1980 for four lanning of Pune-Solapur section of NH-9 in Km 144/400 to Km 249/000 at Village Pakhani, Chikhali, Hivare, Dist. Solapur in the State of Maharashtra. Following discrepancies has been observed in the said proposal:-

- 1) Barest Minimum demand certificate by DCF, Solapur not enclosed in the proposal.
- 2) Copy of the Administrative approval/Technical Approval is not enclosed in the proposal
- 3) The NBWL in their 18th Meeting date 12/04/2010 granted the clearance of the said proposal CCF (WL), Pune vide their letter No. A/Survey No.A/Survey/TA/342/10-11, dated 17/07/2010 granted the permission to execute the work. The said copy not enclosed in the proposal.
- 4) Site Inspection geo tagged photos not enclosed in proposal.
- 5) The proposed road passing through Great Indian Bustard Wildlife Sanctuary. The same highlighted wildlife distance in Sol toposheet with scale 1:50,000. The same needs to be submitted.
- 6) Consolidated KML file showing forest and non forest area along with his properties to be submitted.
- 7) Proposed CA area KML file not submitted along with proposal.
- 8) Details of minor bridge and culvert box not enclosed in the proposal. The same should be shown in KML file.
- 9) Gut No.8,9 showing status on 7/12 extract is land diverted to D.P.A.P and Gut No.6 showing status on 7/12 extract is land diverted to Sarpanch Grampanchyat Chikhali. Forest land not seen in 7/12 extract. Clarification to be needed.
