Subject: Proposed forest land (protected forest) diversion of 1.692 ha for two construction drain by UP Jal Nigam on right side of Amroha Kanth Road (MDR 150) from chainage km 21.840 to km 26.540 in District Amroha (UP) with felling of 55 no. of trees-reg.

Ref: Letter no. 54/Amroha/25152/2017 dated 7th July 2017
Sir,

In reference to your above mentioned letter where approval for above referred forest land diversion proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. Information at A-3 (xvii) regarding person making application on behalf of user agency is incomplete as the name and signature of authorised person has not been authenticated.
2. Information at B-2.3 village wise breakup of forest land has not been provided.
3. Geo referenced map uploaded with the proposal at C-(iv) of part I does not incorporate geo coordinates of all key points defining the proposed forest land for diversion.
4. Information at D-(ii) (a) in part I is superfluous.
5. The land schedule of proposed forest land should be chainage wise providing requirement of forest width and details of balance PF.
6. The information at Sr No. 5 of part II regarding working plan prescription for proposed forest land diversion is incorrect.
7. Details of forest offence (violation of the tune of 0.5 ha) registered in this matter needs submission.
8. Proposed Compensatory Afforestation area may get revised depending upon imposed penal CA in this matter.
9. Kml file of proposed compensatory afforestation is to be uploaded in part II.
10. Site Inspection Report of DFO does not mention legal status of forest land which need correction.

Therefore, the proposal is hereby placed under EDS category for rectification/revision of the same as per the observations made above in point wise manner.
