Subject:- **Diversion of 12.41 ha of forest land under the possession of Forest Department(river bed area)proposed for extraction of sand, stone and bajri from bed of river Yamuna, in favour of M/S Akhilesh Enterprises SPA Kuldeep Singh, within the jurisdiction of Paonta Forest Division Distt Sirmour, HP .**

Kindly refer to your office letter No.C-X-19/Paonta Sahib/2485 dated 27.07.2020, on the subject cited above.

2. The proposal received has been found incomplete. The following shortcomings have been noticed in the proposal which are to be completed. The proposal folders received are also returned herewith for necessary corrections. All the requisite documents may please be placed in the proposal folder with proper numbering and index.

1. There is difference in estimated cost of the project mentioned against column No.A-1(vii) of online part-I and mentioned against column No.1(iii) in hard copy of part-I. In online part-I, 12.1 lac have been mentioned and hard copy 3.3 crore have been mentioned. The estimated cost of the project should tally as mentioned in hard copy and in online part-1.
2. There is difference in the approximate distance mentioned in online part-II and mentioned in hard copy of part-II. In online part-II, against column No.7, approximate distance, '0.150' Kms has been mentioned whereas in hard copy against column No.7(ix), '100 mtrs', has been mentioned. The distance mentioned in online and hard copy should match.
3. Against column 8(iii), 'No', has been mentioned. As per latest instructions of GoI, the distance of the proposed project from the WL sanctuary / Eco- sensitive zones is required to be uploaded as an additional document against additional information details in online part-II. The requisite document is required to be obtained from the DFO concerned for uploading against additional information details in online part-II.
4. Against column No.13(iii), although digital map of CA site has been uploaded but has not been signed by DFO concerned. Further on the map, the heading has been mentioned, ' Digital land use map for penal CA site' whereas the digital map is for CA site. Heading is also required to be changed in digital CA site map.

5. Against column No.13(iv), although map of CA site on toposheet has been uploaded but has not been signed by DFO concerned. Further on the map, the heading has been mentioned, 'Toposheet map for penal CA site' whereas the map on toposheet is for CA site. Heading is also required to be changed in CA site map on toposheet.
6. CA site map on toposheet has not been found placed in the proposal folders.
7. Against column No.15, instead of uploading the site inspection report of DFO concerned, hard copy of part-II has been found uploaded. Against this column, site inspection report of DFO is required to be uploaded.
