महोदय,

उपरोक्त विषयान्तर्गत आप द्वारा ऑनलाईन प्रेषित प्रस्ताव का परीक्षण उपरांत निम्नांकित बिन्दुओं पर सूचनाएँ/स्पष्टीकरण अभी भी दिया जाना अपेक्षित है:-

1. NPV rates are not taken as per crop density.
2. As per part II, rare and endangered flora and fauna found in the area but not mention in site inspection report. Although mitigate measures for the species have not been taken.
3. CA scheme is provided for 9252348 for 4 ha which is more than prescribed model while estimate provide for 2313087 only. 32.19 ha non forest land has been provided under different road proposals in different patches. It would be better to make scheme patch wise and charge accordingly.
4. DCF has not been mention legal status of proposed forest land and justification for recommendation.
5. As per available KML files, partial area of NFL comes under notified forest area.
6. The proposed forest land falling inside the forest block Santora and Rajpur C but copy of notification of Shahbad is uploaded. Justified it.
7. Alternative routes are not taken properly. KML file of the alternative routes is to be provided.
8. Employment details are fictitious.
9. The proposal is falling inside the conservation reserve. Please attach copy of approval of Chief Wild Life Warden.
10. DCF has taken 6 feet wall along the road which is not as per wildlife management. CCF must reconsider and comment accordingly.
11. Project cost is 300 lacs but as per imposed levies by DCF is more than 300 lacs. How the project is feasible? Project cost should be revised.
