Sir,

Please refer the State Govt letter on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. I am to inform that the proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980 and rules/guidelines framed thereunder and the following clarification and lacking information/documents is to be submitted:-

- 1. The status on 2% NPV realization of the forest land involved in the 'Nambar PML' and the total forest area involved in the 'Nambar PML'.
- 2. To clarify whether forest clearance under section 2 (iii) has been granted of the forest area involved in the PML or not as per Ministry's letter dated 24.06.2015.
- 3. The lay out map of the propose area with proper title of the proposal name indicating the drilling location 'NRAH', approach road, etc with proper legend.
- 4. The detail list of the exploratory drilling and production locations in the 'Nambar PML' indicating the legal status of the land, GPS coordinates and map indicating the same along with their forest clearance status.
- 5. The cumulative impact study report of the block of PML area where the drilling location "NRAH" has been proposed.
- 6. The current status of the environment clearance of this instant proposal.
- 7. The GPS coordinate of the proposed drilling location 'NRAH' as the submitted coordinate is for the proposed plinth area.
- 8. The human elephant conflict mitigation and conservation plan approved by CWLW as recommended by the State Govt.
- 9. The current status of the Forest (Right) Act, 2006 certificate of the proposed area.
- 10. The number of the bore hole and its size involved in this proposal.

- 11. The revised NPV calculation of the proposed area as per the Ministry letter File. No. 5-3/1011-FC (Vol-I) dated 21.03.2022, if not submitted.
- 12. The undertaking certificate of CA, NPV and addl. NPV by user agency mentioning the proposal name.
