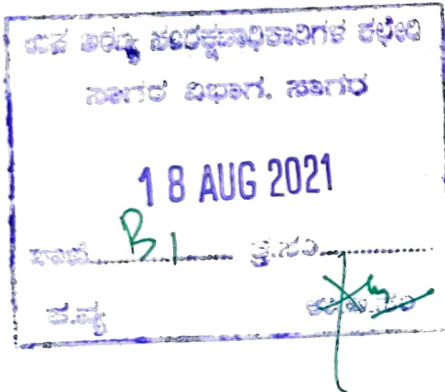

This being a linear project, it is requested that the details of 'encroachment' / settlement in the form of cultivation, present status of settlement of rights, status of FRA compliance, NOCs from claimant in the case of claim being already settled in their favor, etc may kindly be furnished. It is also requested that a review on the feasibility of upgradation of existing lines may be examined so that diversion of forest land can be avoided / minimized.

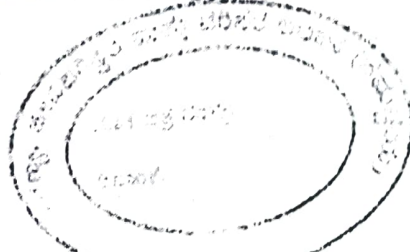
