Vide ref 10<sup>th</sup> cited, the GoI, MoEF & CC, New Delhi has sought for additional information on the subject proposal for further consideration of the proposal, which are as follows:

- (a) The proposed forest diversion is in close proximity with ESZ of Kinnerasani Wildlife Sanctuary which requires Wildlife Management Plan which is recommended by the concerned CCF. The FCA proposal does not contain any specific Wildlife Management Plan. A detail Wildlife Management Plan duly vetted by the concerned Wildlife authorities may be appended with the proposal.
  - (b) An undertaking from User Agency to fund Wildlife Management Plan need submission.
- 2. The proposal is without site suitability certificate from the concerned DFO for the compensatory afforestation.
- 3. As per Decision Support System, out of 1603.67 ha of proposed compensatory afforestation patches 1043 ha patches are falling in canopy class MDF. This requires revision of CA sites or a suitable justification for selecting such areas for compensatory afforestation.
- Proposed CA areas when overlaid on satellite imageries or Google Earth, lot
  of encroachment are observed. This further highlights the need of revision of
  proposed compensatory afforestation or suitable justification from the
  concerned DFO.
- Plantation with Miyawaki Technique between ESZ and mining boundary of 100 m width has been recommended by concerned CCF. The cost estimate of the same and undertaking from User Agency to bear the cost has not been included in the proposal.

In view of the above, the District Forest Officer, Mahabubabad and the Forest Divisional Officer, Gudur WLM are requested to submit the information for the points 2, 3 and 4 and the District Forest Officer, Bhadradri Kothagudem and the Forest Divisional Officer, Kothagudem are requested to submit the information for the points 1(a) and 5 and also to address the User Agency for submission of undertakings for the points 1(b) and 5.
