



Subject: Proposed diversion of 0.075012 ha of protected forest on Aligarh-Raya-Mathura Road (SH-80) at chainage 26.320 km kharsara no. 537 in Bisavali Village for approach road to Retail Outlet of Essar Oil Limited in Aligarh District with felling of 7 (seven) trees-reg.

Ref: Letter no. P-53/14-2-2016-800 (58)/2016 dated 30th June 2017

Sir,

In reference to your above mentioned letter where approval for above referred forest land diversion proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. The information regarding Non Forest Land (NFL) at A-1(ix) of part I is incorrect.
2. The information regarding time period of diversion at A-1(x) of part I is incorrect.
3. The details of non forest land at B-2 of part I is incorrect.
4. The kml file of proposed forest land for diversion is showing tilt and it overlaps with the existing road and the same needs revision.
5. The geo coordinates of the curvilinear portion of proposed forest land diversion has not been provided in C (iv) of part I.
6. The kml file of compensatory afforestation shows overlap with road and existence of vegetation, thus location of CA needs revision.
7. Compensatory afforestation scheme should be framed as per provisions contained in section 3.2 (viii) of the FCA Handbook of 2004.
8. The certificates regarding "Van Swaroop Forestland", "Protected Area or Wildlife Migration Corridor" etc which are for forest related issue has been provided on User Agency letter head and dispatch number rather the same shall be issued from the concerned DFO's office.
9. On various documents name and date of signing authority has not been provided.

Therefore, the proposal is hereby placed under EDS category for rectification/revision of the same as per the observations made above in point wise manner.
