Please refer to your office memorandum No. 2222 dated 7-8-2021 on the subject cited above.


The following shortcomings still have not been attended which may be attended in all respect:-

1. Against the column No. B-2.1 of Part-I details of Division involved, total area 4.2502 ha. is still mentioned, whereas, division wise revised area is required to be filled. Similarly, correction in B-2.2 of Part-I is required to be made.
2. Only one proposal file without proper page numbering has been submitted to this office whereas, two proposal folders are required to be submitted with proper checklist and page numbering. Further, two different Part-I for each division have been placed on proposal folders, whereas, one consolidated Part-I is required to be prepared / submitted.
3. Certificate of Minimum use of forest land has not been countersigned by DCF Rampur, which is required to be countersigned and all documents are required to be placed on appropriate place with page numbering.
4. DCF Rampur has mentioned in para-5 of Part-II 'this project is not prescribed on WP' whereas, the prescription of the forest land proposed for diversion is required to be mentioned as per the working plan against the column.
5. The revised site inspection of the both DFOs are required to be placed in proposal folders and same may be uploaded on web portal.
6. CA has to be proposed over doubled degraded forest land, proposed for diversion. Hence, consolidated CA scheme for doubled degraded forest land has to be proposed either by DFO Ani or DCF Rampur on current wage rates as CA scheme prepared by DFO Ani is not as per the current wage rates.

7. Against the Column No. C (i) & C (II) (b) of Part-I, Ani Division area shown 3.3771 ha. and KML file is uploaded only for Ani Forest Division, KML file for the Rampur Division is also required to be uploaded the said column and necessary correction is required to be made on above column.
8. Against the Column D (i) of Part-I of portal justification for locating the project has not been found countersigned by DFO (s).
9. Against the Column D (ii) of Part-I of portal the copy of map indicating location of alternative examined has neither been signed by user agency nor by DFO(s), which is required to be signed/ countersigned by user agency and DFO(s) as well.
10. Against the Column No. 7 of the Part-II of the Rampur division, the approximate distance of the proposed site for diversion from boundary of forest has mentioned 2.5 KM, whereas, against the column No.(ix) of Part-II of the hard copy, the proposed site is on forest/ government land has been shown, which may be corrected.

You are therefore, requested to make necessary correction in the proposal folders as well as in online mode so that further action into the matter could be taken accordingly. However, the folder as received with the memo is returned herewith for necessary action.
