

Please refer to the State Government's letter No No.FOR. 834/CONS/2018/2436-39 dated 25.09.2020 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The State Govt. is requested to provide following additional information for further processing of the case: -

- 1. The aerial distance of proposed diversion site from any Protected Area.
- 2. The status of FRA, 2006 certificate may be furnished.
- 3. Mutation certificate for CA with Preliminary Notification if any for Mossing VFR.
- 4. In CA scheme submitted there is inclusion of OB labour shed Sheds & MB type quarter which is not under CAF rule, State Govt may kindly clarify.
- 5. As per the Division/District profile, no progress of CA achievement has been mentioned. This may be clarified.
- 6. Site inspection report of CCF, Tezu is for Tr line from Manmow to Chowkham by Power Grid whereas this proposal is from Namsai to Chowkham by Power Department, Govt of Arunachal Pradesh. State Govt may furnish calrification and re-submit the inspection report of CCF, Tezu.
- 7. The Sol toposheet map showing the 3-alternate routes submitted but the analysis of the three alternate routes and reason for chosing the present proposed route is not found enclosed. The same may be furnished.



In continuation to this office letter dated 29.10.2020 under reference above (copy enclosed), the KML / Shape file for the proposed transmission line and compensatory afforestation site submitted along with the proposal has been examined under DSS software in this office. As per the DSS report the CA site proposed over 83 ha includes 16 ha Very Dense Forest, 39 ha of Moderately Dense Forest, 25 ha of Open Forest and 3 ha of NF (Land without forest cover).

In view of the DSS report and its observation for proposed CA site, the State Forest Department may look for alternate sites or submit inspection with with details of vegetation, species, density of vegetation along with photograph along with additional information as per this office leter datd 29.10.2020 for taking further necessary action from this end.
