With reference to above subject, the online proposal (PART-I, II & III) received by this office on 08-06-2020 vide Ref (6) to (9) above and the hard copies of the proposal have been examined. The proposal is however observed to be incomplete in the following aspect.

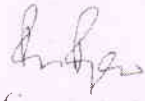

PART-I: Additional Information Details [to be provided by User Agency]	Even though, the Village-wise breakup of forest land in 34 villages falling in four administrative units, viz., Dharwad, Haliyal, Dandeli Wildlife (Kali Tiger Reserve) and Belagavi Division(s) has been uploaded online as well as provided in the hard copies of proposal, the individual Survey Number wise extent of forest land proposed for diversion has not been provided for 30.412 ha forest land in Dandeli Wildlife Division in the proposal. Please ensure that individual Division-wise (including Dandeli Wildlife Division), Village-wise as well as Survey Number-wise breakup of forest land involved in the proposal is uploaded in the Additional Information Details and provided in ink signed hard copies (minimum 3 sets for this office).
PART-II: Item 4(i) [to be provided by respective DCFs]	The Eco-class of the forest land in Belagavi Division has been mention as Eco-Class-IV however the composition of forest tree species in the area suggests the same to be Eco-Class-I same has been reported by the ICT Centre. Please verify the issue and make necessary corrections as per the actual Eco-Class in the general landscape.
PART-II: Item 13 [to be provided by respective DCFs]	1. CA land Suitability Certificates issued by DCF, Haliyal and DCF, Dharwad Division are undated and not in prescribed format. Further, it is not clear whether the propose CA sites in these two Divisions have been inspected by the respective DCF or not. Please ensure that all CA land Suitability Certificates are in the format prescribed by this office vide letter No. KFD/HOFF/A54(FC)/1/2019-FC dated 15-05-2019. It is also to be noted that the date of inspection by DCF has to be mentioned in the said Certificate.

2. As per ICT observations, the CA land proposed in Belagavi Division is also falling in Sy No. 176 of Kakati village. Similarly, as per ICT observations, the CA land proposed in Haliyal Division falls in Mandihala village Sy No. 46, 47, 48, 59 & 60 instead of Sy No. 34, 36, 37, 38 & 44. **Please verify this issue carefully and make necessary corrections, if warranted.**
3. The KML file of CA land in Dharwad Division display an extent of 15.24 ha as against 10.00 ha mentioned in Item 13 & CA Suitability Certificate. Please ensure that
4. GPS reading of all corners of CA land parcels have not been provided in Haliyal Division.
5. Hard copies of Geo-Referenced Maps of proposed CA land parcels in Belagavi Division have not been provided. Similarly, the hard copies of Topo maps and Geo-Referenced Maps of proposed CA land parcels in Haliyal Division have not been provided. **Please ensure that the following information/documents are duly provided in the hard copy of the proposal (minimum 3 ink-signed sets for this office).**
 - a. Survey of India Topo sheet(s) on 1:50,000 scale showing the proposed CA land parcel
 - b. Geo-Referenced Maps showing the proposed CA land parcel(s) super imposed on the village maps with **GPS readings** (Datum WGS 84: in Degree, decimals) of all corners such land parcels
 - c. CA schemes prepared in accordance with Para 2.8 (ii) of the Government of India FC guidelines
 - d. CA land Suitability Certificates in prescribed format

You are therefore, directed that above information/documents is carefully uploaded online as well as provided in hard copies (minimum 3 ink-signed sets) to this office immediately.
