Sub : Carry out Tree enumeration in connection with construction of Khurdha Road – Bolangir New BG Rail Link Project from Km. 143.33 to Km. 180

Ref:- Joint Site Inspection held on dt. 24.08.2021 & 25.08.2021

Sir,

With reference to the above cited subject, it is to inform you that, during joint site inspection held on dt. 24.08.2021 & 25.08.2021 in presence of Forest, Revenue and Railway officials for construction of Khurdha Road – Bolangir New BG Rail Link Project from Km. 143.33 to Km. 180.00 following discrepancies were noticed.


1. Sl. No. of the trees were invisible.
2. Existing tree species were mismatched with provided tree enumeration list.
3. Trees inside Reserve Boundary were mentioned in DLC Forest List.
4. The girth class of some trees were underestimated and beyond permissible tolerance limit.
5. Proposed Right of Way was not clearly visible.

Hence, it is requested to make necessary arrangements and coordinate with the Forest Deptt., Revenue Deptt., OFDC Ltd. Officials for the above purpose. **The tree enumeration work shall start from dt. 30.08.2021 and the enumeration work should be completed by 09.09.2021 with the above points and re-submitted in this office by 15.09.2021 for expediting the project work.**

Further, you are requested to ensure the **chainage wise (with 100.000 m interval)** tree enumeration list in the prescribed format **(Copy enclosed)** separately i.e. Reserved Forest, Proposed Reserved Forest, Demarcated Protected Forest, Revenue Forest Land, DLC Land, Non-Forest Govt. Land & Deemed Forest Land wise through the concerned Range Officer with due signature of the Officials/ Staff involved in the enumeration work.






