On verification of the said report, it is found that the Chief Conservator of Forests, Bhadraburi and the District Forest Officer, Mahabubabad have informed that violation has been reported against UA stating that FRO has booked case by POR in 23-08-2021 and compounded for Rs. 61,484/-. However, the details on the action taken against the concerned forest officials and UA are not furnished.

In view of the above, the Chief Conservator of Forests, Bhadraburi circle and the District Forest Officer, Mahabubabad are requested to look in to the matter personally and furnish the Action Taken Report against concerned the Forest Department officials and User Agency for forwarding the EDS reply to the Regional Officer, GoI, MoEF&CC.
