SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF/DFO

A proposal has been received by this office from Sh. Pawan Goyal, Partner of M/s STJ Infra, village Nabha, Zirakpur, Distt. S.A.S.Nagar, Punjab for diversion (under FCA-1980) of 0.014 Ha. of forest land for non-forestry purpose. The subject envisages the use of forest land for construction of approach road to M/s STJ Infra for commercial Purpose/Colony at village Nabha, Tehsil Zirakpur on Zirakpur-Patiala road NH 7 Km 341.565 LHS (old NH 64 KM 2.435 RHS), under Forest Division & Distt. S.A.S. Nagar, Punjab. The site inspection of the land involved in the proposal has been done by me on dt. 28/4/2021.

On inspection of the site, it is found that the land required by the user agency is a **Protected Forest** measuring **0.014 Ha.**

DETAILED REPORT ON VIOLATION OF PROVISIONS OF FOREST ACTS

Subject: Diversion of 0.014 hac. of forest land for construction of approach road to M/s STJ Infra for commercial Purpose/Colony at village Nabha, Tehsil Zirakpur on Zirakpur-Patiala road NH 7 Km 341.565 LHS (old NH 64 KM 2.435 RHS), under Forest Division & Distt. S.A.S. Nagar, Punjab.

- a) 0.0130 ha. of forest land broken & No tree has been felled on this area by the user agency.
- b) The person responsible for the contravention of provision of Forest Acts is **Pawan Goyal, Partner of M/s STJ Infra, village Nabha, Zirakpur, Distt. S.A.S.Nagar, Punjab.**
- c) In this case Range Forest Officer, Derabassi has reported to this office that the user agency has violated the rules of Indian Forest Act. 1927. The Damage Report No. 1816657 dt. 01.12.2020 to be issued by the concerned Forest Guard against the user agency. That the compensation Rs. 20,575/- has been realized from user agency for 0.0130 ha. of forest land broken. The user has now stopped the work and applied for NOC under section 2 of the FCA 1980. The user agency has committed violation in this case, for this violation two times Penal Compensatory Afforestation is recommended.
