

EDS on Proposal No.FP/HP/Road/11362/2015

Diversion of 0.147 ha of forest land in favour of HPPWD for the construction of road from Bhali to Bhanivari , Kms 0/00 to 1/900 within the jurisdiction of Nurpur Forest Division Distt.Kangra, HP.

1. Against column C(iv) in online part-I, although the digital map of proposed road has been uploaded, but as per latest instructions of GoI, against this column map of the proposed project duly signed by the XEN and DFO concerned is required to be uploaded.
2. There is difference in the employment likely to be generated mentioned in online part-I and mentioned in hard copy of part-I. In online part-I, against column No.E(ii), '60' and against column No. E(iii), '150', has been mentioned whereas in hard copy against column No.1(vi), 'about 9000 mandays, has been mentioned. The employment likely to be generated mentioned in online part-I and mentioned in hard copy of part-I, should tally. Necessary corrections are required to be made in online part-I and hard copy of the proposal.
3. There is difference in the approximate distance mentioned in online part-II and mentioned in hard copy of part-II. In online part-II, against column No.7, approximate distance 0.500Kms has been mentioned whereas in hard copy against column No.7(ix), 'The land proposed for diversion is within the forest', has been mentioned. The distance mentioned in online as well as in hardcopy should tally.
4. Against column No.8(i), Details of wildlife present in and around the forest land proposed for diversion, 'The proposed land does not falls present in and around any nation park or Wild Life Sanctuary.', has been mentioned. Details of wild life present in and around the forest land proposed for diversion is required to be mentioned against this column.
5. Against column 8(iii), 'No', has been mentioned. As per latest instructions of GoI, the distance of the proposed projects from the WL sanctuary/ Eco-sensitive zones is required to be uploaded as an additional document against additional information details in online part-II and if falling within the 10 Kms of protected areas, the comments of Chief wild life warden of the State are required to be obtained for uploading against additional information details.
6. Against column No.13(i) to (iv), the details of CA patch has been given. The forest area proposal for diversion is less than 1.00 ha hence the details of CA is not required to be filled against this column. CA is required to be proposed in terms of number of plants. The CA scheme in terms of number of plants, digital map and map of CA site on toposheet is required to be uploaded against additional information details.
7. Against column No.16, the column of recommendations, instead of uploading the recommendations of DFO concerned in shape of part-II, a note on recommendations has been found uploaded. Now it can not be uploaded.
