I wish to invite your kind attention to the reference 1st cited above. Therein the Conservator of Forests, Dharmapuri Circle during the field inspection on 21.7.2023 has instructed to inform the User Agency for the following requirement and rectifications.

The actual area proposed for diversion was not marked on the ground. Hence it shall be marked on the ground with stations numbered along with GPS readings for the stations, which can be verified during inspection by CF.

Accordingly in the reference 3rd cited above, the proposal received at online is scrutinized in this office and the replies furnished by the User Agency for the EDS raised by this office is scrutinized.
