Sub: Proposal for diversion of 4.75 ha forest land for construction of Halaipani HEP (16 MW) by Halaipani Hydro Project Ltd. in Anjaw District of Arunachal Pradesh.

Sir,

With reference to the subject and letter cited above, I m directed to inform that the information submitted by State Govt letter under reference (i) above has been examined in this office and following lacking information are observed:-

- (i) The approved muck dumping plan by the concerned DFO along with its GPS coordinates.
- (ii) The identified 9.611 ha CA area is covered with 2.204 ha moderately dense forest, 8.204 ha open forest and 0.203 ha is non forest as per DSS. State Govt is therefore to conduct site inspection of the identified CA area by an officer not below the rank of Conservator of Forest and report to be submitted mentioning vegetation and forest cover density with photographs of the inspecting officer taken at the site, or else, an alternate CA site is to be submitted along SOI maps, site suitability certificate, GPS-coordinates, shape file etc.
- (iii) The current status on mutation and notification of the identified CA site of 9.50 ha in Pailo Village Forest Reserve.
- (iv) The complete action taken report along with the following are to be submitted:-
 - (a) Action initiated by the State Govt against the responsible official of forest department, if not the reason thereof.
 - (b) The details of the administrative and legal action taken report against the responsible officer and other criminal proceeding against the reported violation.
 - (c) To estimate the panel provision for the act of violation of F(C)Act, 1980 in report to the proposed diversion area as per Para 1.21 of F(C)Act, 1980, guideline, 2019.

State Govt. is requested to kindly furnish the above requisite information to this office for further processing of this proposal.
