With reference to the above mentioned subject and letter under reference, I am directed to inform you that after examination of the proposal it is observed that the proposal have some shortcomings. Thus I am directed to request you to submit/upload the following information/documents:

- a) Alternative examined for the proposed road along with comparative statement shall be submitted.
- b) Distance from nearest Protected area/Wildlife Sanctuary/National park shall be submitted and CWLW comments, if applicable.
- c) CA is proposed over 4.60 ha non-forest land as per forwarding letter of State Govt. of Gujarat dated 17.08.2020 and following points were observed as per DSS:
 - i. 3.47 ha out of 4.60 ha falls in Forest Compartment No. 290 (Old 160 pt) Khambhaliya Range, Jamnágar.
- d) The CA as per FCA guidelines 2019: CA land shall be checked and correct location and KML file out side Forest Land shall be submitted.

Further, necessary action will be carried out after receipt of above information.
