महोदय,


उपरोक्त सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरांत निम्नलिखित कमियां पाई गयी हैं:

1. At para A-1 (iii) benefit details are furnished instead of short narrative of the project.
Action Required:- The State Govt. may upload the short narrative of the project at para A-1 (iii) online.
2. The documents uploaded as additional documents at serial no. 03 and 06 regarding certificate of minimum use of forest land and additional NPV is not c/s by DFO.
Action Required:- The State Govt. may upload the certificate of minimum use of forest land and additional NPV duly c/s by DFO.
3. The details of wildlife at para B (i) in online Part-II is not given by the State Govt.
Action Required:- The State Govt. may upload the details of wildlife at para B (i) in online Part-II.
4. The proposal involve violation of FCA, 1980 and listed in the list of cases submitted to Hon'ble High court of Shimla at no. 540 of 2183 cases for which the inspection report of DFO is also placed in the file. The whole area 2.9934 is broken.
Action Required:- The State Govt may submit the inspection report under the chairmanship of CF rather than DFO as per the direction of Hon'ble court.
5. The geo-referenced map & KML for penal CA which is twice in extent of area broken i.e 5.98 or 6.0 ha is not uploaded at para 13 of part II online.
Action Required:- State Govt. may upload the geo-referenced map & KML for penal CA (5.98 or 6.0 ha) at para 13 of part II online.
