
With reference to the subject and reference cited above, I am directed to inform that the proposal submitted has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder and the following information are found lacking:

- (i) To submit the SoI toposheet depicting the proposed CA area in the polygons features and not in point feature as submitted.
- (ii) The name of the Reserve Forest and Protected Forest of the area involved in this proposed area along with the compartment No.
- (iii) The compensatory afforestation scheme is to be authenticated by the competent authority.
- (iv) The total length of proposed transmission line.
- (v) The Forest Right Act, 2006 certificate in the prescribed performa.
- (vi) The 3D diagrammatic Sketch of the proposed transmission line showing the numbers of tower and Right of Way authenticated by the competent authority.
- (vii) The GPS coordinates of the starting and end point of the transmission line passing through the forest area.
- (viii) The GPS coordinates and photographs of the sample plot for the tree enumeration showing trees marked in field and serially numbered with red/yellow paint.

- (ix) The soft copy of shape file of the proposed transmission line is to be submitted in polygon feature and not in polyline feature as submitted.
- (x) The proposed compensatory afforestation area is having Moderately Dense Forest as per the DSS software, however as per the Google Earth the area is having no vegetation but like some plantation area/ agriculture field .State Govt to clarify the same.
- (xi) State Govt to complete the uploading process in Ministry's web site as it is showing pending with the State Govt.

State Govt is requested to kindly furnish the above information in the complete manner immediately so that the proposal may be discussed in the REC meeting scheduled to be held on 15.09.2017.
