Sir,

With reference to the subject and letter cited above, I am directed to inform that the proposal has been received in this Regional Office, Shillong on 09.07.2018. After examination the proposal in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder, the following information are found lacking:

- (i) The original copies of all the submitted documents as the same has been submitted in the Xerox copies.
- (ii) The details of the existing road along with original and proposed right of way.
- (iii) The Chief Secretary certificate for non- availability of the non forest land for the proposed Compensatory afforestation.
- (iv) A brief of the remaining stretch of the road.
- (v) The employment likely to be generated from the project.
- (vi) To submit the complete Part-I, Form A as the submitted one is not complete.
- (vii) The sketch of road profile showing the proposed and existing ROW.
- (viii) To submit the shape file of proposed road and Compensatory afforestation site as the same has not been found in the submitted CD.

State Govt is further requested to clarify whether the proposed area is for creation of border security related infrastructure, if so, State Govt may take necessary action for processing of the proposal as per the Ministry letter F.No. 11-246/2014-FC dated 19.04.2018 (copy enclosed), or if not, then the State Govt is requested to kindly furnish the above information to this office for further processing of this proposal.
