Sub: Proposal for diversion of 110.817 ha of forest land for laying of 132 KV Transmission Line from Namsai to Miao under Comprehensive Scheme for strengthening of T & D system in Changlang and Namsai District of Arunachal Pradesh by Power Department, Government of Arunachal Pradesh.

Sir,

Please refer to the State Government's letter No. FOR.831/CONS/2018/2516-21 dated 05.11.2019 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The State Govt. is requested to provide following additional information for further processing of the case: -

- 1) As per the DSS software the proposed compensatory afforestation site selected over 105 ha under Hapoli Forest Division includes 4 ha Dense Forest, 64 ha Moderately Dense Forest and 37 ha of Open Forest. The State Govt may explore alternative site for compensatory afforestation for this proposed site.
- 1) As per the DSS software report it appears that the proposed transmission line is touching Namdapha Tiger Reserve and elephant grid. It may be clarified and commented upon by CWLW.
- 2) In the CA site over and area of 116 ha under Nampong FD, 23 ha of proposed area falls under River bed as per DSS software report. This requires clarification from State Govt, as to whether the site is suitable for taking up compensatory afforestation.
- 3) The State Govt may re-examine the CA scheme at sl n. 14 for proposal of modified improved standard size Bascha (MB) type quarter which is not considerable. Similarly, construction of OBT labourer sheds are also to be re-examined for CA scheme at Miao, Diyun RF & USF.
- 4) The cost for CA submitted in the forwarding letter is Rs. Rs. 6,59,15,200 whereas in the Scheme for CA submitted at Miao, Diyun RF & USF over 117 ha it is projected at Rs. 3,28,30,322/- and at Kassin Puttu Ago VFR over 104.90 ha it is projected at Rs. 2,51,29,000/- with total amount of Rs. 5,79,59,322/- which is not matching with that in the forwarding letter which is projected Rs. 6,59,15,200/-. Clarification may be furnished.
- 5) The distance of the proposal from the nearest Protected Area with respect to Namsai Forest Division.
- 6) State Govt may furnish a correct Geo-reference map of the proposed CA site with accurate GPS Co-ordinates.

However, as per Ministry's letter dated 12.08.2020, it is provided that in case the State Government has been requested to furnish clarification or additional information relating to a proposal, the reply should be made available to the Central Government within 90 (ninety) days. In case the required clarification/information is not received within that period the case will be rejected by the Central Govt for non-furnishing of essential information.

In view of the above, the State Govt. is requested to furnish the wanting clarification / information in details as sought vide this office letter dt.26.11.2019 at the earliest as the proposal is pending for many months and to enable this office for taking further necessary action.
