Sub: Proposal for diversion of 1.82 ha of Revenue forest land in village Gothapatna under Bhubaneswar Tehsil of Khordha District for construction of approach road to Gothapatna New Industrial Estate by M/s IDCO under Chandaka (WL) Division

Ref: Your office Memo No.2605 dated 22.07.2022

In reference to your office memo on the subject cited above, it is to inform you that on scrutiny of the above diversion proposal, the following shortcomings have been noticed:-

- (i) Check list of the proposal furnished in the DP has not been signed by the DFO, Chandaka (WL) Division and not countersigned at your level as well.
- (ii) Sanction order/ Administrative approval order of the project has not been furnished by the UA in the DP.
- (iii) Detailed note of the project furnished in the DP at Page No.16/DP Being a linear project the GPS co-ordinates of the start point and end point of the proposed road has not been furnished. Further, the total length and width of the proposed road to be constructed passing through the revenue forest land having mixed plantation has not been furnished.
- (iv) The proposed approach road passes through revenue forest land having mixed plantation of Acacia, Chakunda, Kaju etc. but the owner/ organization and year of such plantation has not been furnished in the DP.
- (v) Tree Enumeration (Page No.26-48/DP) The entire tree enumeration list furnished in the DP alongwith girth class wise abstract of trees on Revenue Forest land has not been authenticated by any Revenue staff and Tahasildar Bhubaneswar.
- (vi) Alternate alignment (Page No.20/DP) The DFO, Chandaka (WL) Division has not countersigned.
- (vii) FRA Certificate (Page No.25/DP) Though undertaking has been submitted by the User Agency for submission of FRA certificate from the District Collector Khordha, but the initiative so far taken by the User Agency for obtaining such FRA certificate from the District Office, Khordha has not been furnished alongwith the undertaking.



(viii) The DGPS surveyed CA land map furnished on cadastral map of mouza Bidyadharpur Sheet No.1 is not clear and visible.

In view of the above, the diversion proposal received in triplicate is returned herewith for necessary compliance and resubmission of the same at the earliest for taking necessary action at this end.
