With reference to the above cited letter on the captioned subject, it is to inform you that during the Site Inspection of your aforesaid forest diversion proposal on dt.29.07.2021, it was observed that, (1) Demarcation on the ground and pillar posting as per DGPS survey in respect of all the 54 nos. of patches was incomplete, pillar posting is necessary for clear visibility of the proposed forest area to test the correctness of the forest diversion proposal (2) The pillars needs to be numbered and GPS location written on each pillar for proper assessment. (3) The enumeration of trees standing over the proposed forest land has not been done properly and most of the plots is incomplete (4) The enumeration list of trees standing over the non-forest government land has not submitted (5) The cost benefit analysis incomplete lacking proper details.

As such you are requested to kindly take necessary steps and after completion of the said work intimate to this office as early as possible so that a further date for site inspection can be planed keeping in view the timeline given by the MoEF for the said proposal.

Hence, the previously submitted Diversion Proposals (in six sets) are returned herewith for necessary compliance at your level and re-submission after compilation in each respect to this office for taking further action and onward transmission to higher quarters.
