


Construction of Jahopra-Shikhar-Basti Motor Road (12.00 Km) (4.987 ha)

The reply of this office EDS dated 24.06.2016 has been uploaded by the State Govt. on 11.07.2017. Following shortcomings still remain in the reply/proposal:-

1. The reply of this office offline EDS dated 05.07.2016 (copy attached) has not been submitted by the State Govt.
2. The component wise breakup has not been given in para-B-2.4 of online Part-I. Here, the breakup of land required for construction of road and the land required for muck dumping and any other component of the road is required to be given which has not be done.
3. Copy of map indicating location of alternative examine has not been uploaded in para-D (ii) of online Part-I.
4. In the village wise breakup, the forest land has been shown against 3 villages namely: Jahopara, Kasnaula & Basti but the name of one village i.e. Jahopara only has been mentioned in para-2 of the proceedings of Village Level Committee meeting under FRA.
5. GIS software generated geo referenced digital map for the proposed CA area has not been found uploaded at L (v) of online Part-I instead the map has been uploaded as additional document at S.No. 1.
6. The reply of point no.10 of EDS regarding presence of MDF over 3.00 ha area identified for CA has not found satisfactory. Nodal Officer has not given any comment on the issue. Moreover, nothing have been mentioned about the no. of trees and the density of vegetation in the area identified for CA in the certificate issued by DFO.
7. The site wise legal status of land including dimensions identified for disposal of muck has not been given in the muck disposal plan. Further, nothing has been mentioned about the query made in point no.12 of EDS dated 12.06.2016.
8. The original copy of the FRA certificate and geo referenced digital maps for the forest land proposed for diversion and the land proposed for CA have not been submitted.
9. The no. of trees is mentioned as 324 in the online Part-II but the no. of trees is mentioned as 358 in the enumeration list provided in the hard copy of the proposal. Revised enumeration list showing species wise and dia/girth class wise no. of trees is required to be submitted.

State Govt. may remove above shortcoming and submit/upload necessary information/documents/clarification.

In the FRA Certificate issued by the District Collector, against point No. 1 & 2 it is mentioned "Not application as there are no habitation belonging to Scheduled Tribes and Other Traditional Forest Dwellers", which is not correct. State Govt. may submit revised FRA Certificate as per as performa without mentioning 'not applicable'.
