Sub: Diversion of 0.78 ha of Forest land for Construction of Road from Mantlai to Gamsadu, District Udhampur, UT of Jammu and Kashmir.-reg.

Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of **0.78** ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the Govt of J&K the following information/clarification are still required to be submitted:

- (i) Alternatives examined in the proposal to be depicted in map and submitted.
- (ii) Revised KML of proposed to be submitted. KML shows only one segment of forest patch while as three segments are shown in the lay-out map and the details of diversion in Part-I.
- (iii) NPV to be calculated with respect to rates applicable in Protected Areas.
- (iv) CF in part III has not recommended any area for diversion
- (v) If the muck is to be dumped in NFL area, UA will be required to furnish exact location KML of the dumping site.
- (vi) The Undertaking certificate for CA, NPV and Add, NPV does not have proposal number also it is to be countersigned by the concerned competent authority.
- (vii) Employment is shown as **0** under column E (i) of Part I. Need to clarify
- (viii) WL clearance certificate to be submitted after Stage-I.
- (ix) The specific recommendation uploaded by DFO/Wildlife Warden does not mention proposal number.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
