Madam,

With subject and reference cited above, I am directed to inform that the State Govt. vide letter under reference has submitted the above mentioned proposal to this office seeking prior approval of Central Government under Section-2 of Forests (Conservation) Act, 1980. On scrutiny of the proposal, following was observed.

- i) State Govt. has not submitted the proposal through Parivesh web portal of the Ministry. In Parivesh web portal, the proposal is showing pending at DFO/DCF level of the State Govt.
- ii) Since, the project is PMGSY project and is a Central Sector Project, as per Ministry's letter No.FC-11/50/2020-FC dated 18.08.2020, in Online application form in PARIVESH portal, the name of user agency should be Central Govt. agency instead of State Govt. so as to claim the dispensation of CA over double the degraded forest land instead of equivalent non-forest land.
- iii) The DFO, Phulbani has not uploaded the KML file, C.A. Scheme, Sol toposheet & Geo reference map of C.A. area of the proposal in Parivesh web portal.

It is therefore requested to furnish the above desired information to this office for further necessary action.
