Subject: Forest Land proposed to be diverted for Widening and Strengthening of NH-234 Triwa-Bela Road from CH.142.00 to 123.00 in Kannauj District with felling of 2296 trees-reg.

Ref: Letter no. P-13/14-2-2017-800 (8)/2017 dated 29th June 2017

Sir,

In reference to your above mentioned letter where approval for above referred forest land diversion proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. As per the GIS DSS analysis of kml files for proposed forest land diversion (uploaded at C of part I) following issues need rectification:
 - a. The proposed forest land area for diversion shows overlap with existing road which is to be rectified.
 - b. Kml file needs submission in CD also.
2. Geo referenced map uploaded with the proposal at C-(iv) of part I need geo coordinates of all key points which will define proposed forest land for diversion.
3. The land schedule uploaded with the proposal does not provide details of balance of RoW which will remain after proposed forest diversion.
4. Various documents of the proposal submitted are without name and date of the signing authority.
5. The proposal is without enumeration of pole crop (< 30 cms gbh) which later on necessitates request for approval for additional tree felling from the State Government.
6. Kml file of proposed compensatory afforestation site has not been submitted in CD and in case of online uploaded one access is denied. The necessary GIS DSS analysis has not been carried out due to non availability of particular kml file.

Therefore, the proposal is hereby placed under EDS category for rectification/revision of the same as per the observations made above, in point wise manner.

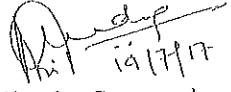

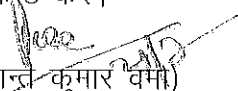
