Sir,

In reference to your above mentioned letter where approval for above referred forest land
diversion proposal was sought; I have been directed to convey following shortcomings of the proposal
for necessary rectification:

1. Information at A-3 (xvii) regarding person making application on behalf of user agency is incomplete as the name and signature of authorised person has not been authenticated.
2. Geo coordinates of all key points of proposed forest land diversion need submission.
3. Information regarding working plan prescription at Sr. No. 5 part II is incorrect.
4. Various documents of the proposal are without name and date of the signing authority.
5. Site Inspection report of the concerned CF is not enclosed whereas the proposal is of diversion > 40 ha.
6. Certificate regarding "Van Swaroop" land has not been provided with the proposal.
7. A brief profile of the proposal covering different aspects shall also be submitted by the user agency.

Therefore, the proposal is hereby placed under EDS category for rectification/revision
of the same as per the observations made above in point wise manner.
