

महोदय,

मुझे आपका ध्यान उपर्युक्त प्रस्ताव की ओर दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण) अधिनियम, 1980 की धारा-2 के अनुसार गैर वानिकी उद्देश्य के लिए 0.0068 हेक्टेयर वन भूमि की मांग की गई है।

- 2. अत :प्रस्ताव से सम्बंधित निम्नलिखित जानकारी भेजने का कष्ट करे-:
  - Vegetation Density uploaded in Part-II as 0.00 which is erroneous.
  - ii) As per Part-II of main application form and Site Inspection Report by DFO concerned, this is a violation of FCA, 1980 case. As Part-II as well as Site Inspection Report by DFO concerned is silent about the extent of forest area broken in violation of FCA, 1980, therefore, detailed violation report clearly showing the total area broken in violation of IFA/FCA may be submitted.
  - iii) The CLU has been Issued in the name of Makhan Palace situated at village Dhaini Paswal whoroas in other all documents, the name of village is Paswal, which needs clarification.
  - iv) Layout plan is neither approved from competent authority nor countersigned by DFO. Hence, revised layout plan with component-wise/dimension-wise forest as well as non-forest area requirement in distinct colour for the instant project including all building structures duly approved and signed by the competent authority and counter signed by the DFO concerned be submitted.
  - v) NOC from PWD duly countersigned by the DFO concerned as NOC neither signed by the PWD authority nor any official seal is there.
  - vi) Status of Environmental Clearance, if it is not applicable for this project, User Agency may provide valid certificate from SEIAA.
