- In Certificate of Check list the Area of Diverted land has to be changed from 7.00Ha to 4.81Ha in S.No.6 uploaded under additional information details.
- ii. In S.No.4 the certificate of Non Forest land (No Alternative land) provided by District Collector, Dharmapuri is repeated in S.No.7 uploaded under additional information details.
- iii. In Certificate of minimum use of Forest land the Area of Diverted land has to be changed from 7.00Ha to 4.81Ha in S.No.10 uploaded under additional information details.
- iv. In S.No.11 the certificate of NPV undertaking should be changed as Certificate of additional NPV undertaking and the undertaking is on Block Development officer not on Block development office.
- Area of Diverted land has to be changed from 14.00Ha to 4.81Ha in S.No.12 uploaded under additional information details.
- vi. In the S.No.13 undertaking of lease rent certificate, undertaking is on Block Development officer not on Block development office uploaded under additional information details.
- vii. In S.No.14 the Area of Diverted land has to be changed from 7.00Ha to 4.81Ha uploaded under additional information details.
- viii. The Same and repetition of letter found in S.No.15 and S.no.16 and the Area of Diverted land has to be changed from 7.00Ha to 4.81Ha uploaded under additional information details.
- ix. The FMB has to be enclosed with the form uploaded in S.No.17 under additional information details.
- x. The details of GPS points for the stretches of road in Diverted land area and the CA land area have not been authenticated in S.No.19 and 20 and the same repeated details found in S.No.21 and 22 under additional information details.
- xi. In S.No.24 Geographical reference map for the Compensatory Afforestation land enclosed does not contain the Extent details , this may be rectified.

- xii. In the Form A , Part I , Section L (iv) f , the Diverted land area have to be changed to 4.81Ha with duly Authentication.
- xiii. Some documents are uploaded in multiple copies. Unnecessary documents should be avoided.

Hence, the User Agency is requested to rectify the above shortcomings and the incomplete details may be uploaded on the Parivesh web portal at the earliest and rectified hard copy of proposal need in 5 copies with duly authentication for further action.

It is informed that, only after receipt of the proposal in full shape, further action of the forest clearance proposal will be initiated.
