महोदय,

उपर्युक्त प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित त्रुटियाँ पाई गयी। राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

- 1- The locations of all the villages to be benefited by the proposed road are not marked on the KML file. Accordingly, the State Govt. is requested to mark the locations of the concern villages in the KML file and upload the same in the online portal.
- 2- In the geo-referenced map, the existing roads of Kalika-Dalmoti MR and Tanwari-Baisolti MR are available at both the ends of the proposed road. In view of the fact the purpose of the proposed alignment is not clear because there is no habitation in between these two ends. The concerned DFO is requested to visit the site and comment on the requirement of the proposed road.
- 3- It is seen that, the bridal path is available all along the proposed alignment which is not been examined as an alternate alignment. The State Govt. is requested to submit the examination report/comment on the same.
- 4- The State Govt. is requested to find out the width of the existing bridle path. It's seen that, in the initial half portion the proposed road is almost parallel to the existing path and if required, the same may be widened instead of constructing a new road.
- 5- The State Govt is requested to submit the propose tree enumeration list for 7m width. Further, tree enumeration for the area proposed for muck dumping shall also be submitted separately.
- 6- As per the DSS analysis of CA area 2.0 hectare area is found MDF out of total 4.42 ha area. The State Govt. is requested to revisit the area for its suitability and the concerned DFO must ensure that the area proposed CA is suitable for raising plantation and shall have vegetation density below 0.4. If required, this 2.0 ha area can also be replaced with some other suitable area.
- 7- The villages located at both the end of the proposed road are already well connected. There is no necessity of the proposed road. Further, the road affects 246 trees. The State Govt. is requested to justify the necessity of the proposed road.

- 8- The total forest involved and the numbers of trees affected in the proposed as well as the alternative alignment are also not provided. The State Govt. is requested to ensure that the User agency shall provide the details to alternative alignments.
