1. The Bilapur village was situated in Nagaland Border. It is about 25 K.M from Langting Bazar. There is no road connectivity to reach the area except four wheeler Truck on Kacha muddy Jungle road.

2. Supervision, Inspection and monitoring of plantation may not be done properly due to lack of

communication.

- 3. The labour force has to be procured from far flung area.
- 4. There is no infrastructure to accommodate the labourers.

5. There is no facilities to purchase essential commodities.

6. The labours as well as forest staffs has to walk 25 km on foot to reach the plantation area at

Bilaipur

7. The Plantation work is time bound work which is to be completed in due time. In creation of 425.5 Hac. Plantation a huge numbers of labour to be engaged at a time, unless the success and survival of plantation will be at risk, ultimately it will become a wastage of government fund.

Therefore, taking into account the pros and cons from all aspects, the Bilaipur area is not suitable for compensatory afforestation.

In this connection, I am to inform you that I have identified a plot of land measuring 425.5Hac. at Boro Langherang village area. The No objection Certificate from village authority is enclosed herewith. The area is situated near D.D. Road under Garampani Range, and only 3 KM distance from Thaijuwari Forest Check gate. It is accessible and there will be no problem for supervision, inspection and monitoring of plantation. In this regard, i am to request you to provide 6 (six) sets of Topo-map and herein located the compensatory aforestation area alongwith GPS Coordinates at least 4 corner immediately for onward necessary action.
