Sub: Proposal for diversion of forest land for construction of link road from Shangroo to Nagni Gujjar Basti in Bhaderwah Forest Division by PWD in Bhaderwah Forest Division.

This is with reference to the above proposal. The Conservator of Forests, Chenab Circle Doda/DFO Bhaderwah/User Agency are requested to upload the following documents, within two days:-

1. The survey of India toposheet, geo-referenced map and layout plan has not been authenticated by user agency. An authenticated copies of these documents need to be uploaded in Part-1 of Form-A ---- **Action to be taken by UA.**
2. The proposal for stabilization of muck dumping sites, biological measures has been prepared and uploaded by DFO Bhaderwah. As two number of dumping sites are proposed in forest area, as such, muck disposal plan as per circular issued vide this office communication No. PCCF/FCA/3118/13/53 dated 03-04-2021 need to be prepared and uploaded by the user agency. ---- **Action to be taken by UA.**
3. Form-A K(i)- it has been mentioned that FRA has been completed as "YES", however, a communication addressed to Deputy Commissioner concerned for FRA has been uploaded. Need to be clarified by the user agency. Till the communication from District Collector is received, it should be mentioned as "No". The communication addressed to Deputy Commissioner concerned for FRA need to be uploaded at additional documents in part-I by the user agency----- **Action to be taken by UA.**
4. The name of the forest under column 13(i) of Part-II in which CA site is located need to be given by DFO Bhaderwah----- **Action to be taken by DFO.** ✓
5. In the CA Plan, the area of CA site is 2 Ha, whereas KML file of 0.43 Ha has been uploaded in Part-II of form-A. Revised KML file of CA site need to be uploaded by DFO Bhaderwah. ---- **Action to be taken by DFO**
6. The survey of India Toposheet and geo-referenced map in Part-II of Form-A indicating CA site are not openable on the web portal. These documents need to be reuploaded by the DFO Bhaderwah **Action to be taken by DFO**
