Subject:- Diversion of 3.7904 ha of forest land in favour of JSW Energy Limited, Kuther HEP(240 MW) village Machhettar, PO Channouta, tehsil Bharmour distt Chamba for the construction of LILO from 400 KV double Circuit Transmission Line Lahal to Rajera at Tower No.8 to Pot Head yard for evacuation of Power of JSW Energy(Kuther) Ltd.Kuther HEP 3x80 MW village Machhettar, PO Channouta,within the jurisdiction of Bharmour Forest Division Distt.Chamba, HP.

Kindly refer to your office letter No.D-V/580/G/2061 dated 16.7.2021 on the subject cited above.

2. The proposal received has been found incomplete. The following shortcoming has been noticed in the proposal which is to be completed. Proposal folders received are returned herewith. All the requisite documents may please be placed in the proposal folder with proper numbering and index.
1. Check list is required to be signed by CCF/CF concerned hence check list duly signed by DFO and countersigned by CCF concerned is required to be placed in the folder.
2. As per species involved in the present proposal, the eco class of the forest area proposed for diversion should be Eco Class-V instead of Eco class-VI, whereas against column No.4(i), eco class-VI has been mentioned and bill of NPV placed at P.No.48 of the proposal folder has also been calculated for eco class-VI instead of eco class-V.
3. Against column No.8(i), instead of mentioning the details of wildlife present in and around the forest land proposed for diversion, 'The Proposed forest land does not form the part of wild life sanctuary/ National Park. But it falls within 10 Kms distance from the boundary of Tundah Wild Life Sanctuary. So Comments of DFO Wild Life Chamba is annexed at page 50 in the proposal folder', has been mentioned. Details of wild life present in and around the forest land proposed for diversion is required to be mentioned against this column.
4. Against column No.2 of online part-II, the legal status of the forest land proposed for diversion, 'Protected Forests' has been mentioned whereas in hard copy of part-II, 'DPF', has been mentioned. Thus there is difference in legal status of the forest land mentioned in online and hard copy of part-II. Necessary correction is required to be made in online part-II.
5. In the detail note placed at P.Nos.16-17, it has been mentioned that the detailed survey report of the proposed transmission line had been approved by HPPTCL vide letter No.HPPTCL/DGM/CBA/09/2019-20-744 dated 8.9.2020. But the said letter and transmission plan approved by HPPTCL has not been found placed in the proposal folder. These requisite documents are required to be placed in the proposal folders and also required to be uploaded in online part-I.
6. All the documents placed in the proposal folder either should either be original or attested one. Photocopies placed in the proposal folder should be attested either by user agency or DFO concerned.
