2. In this connection, it is submitted that during the scrutinization of the proposal online and hard copy the following shortcoming are found:

- There is difference in number of population / villagers benefitted in the hard copy of Part-I it is mentioned 2500, Check List-4: 5000 and as per certificate of village benefitted 2697 is found mentioned. Please may be clarified and corrected.
- 2. Toposheet Map and DGPS map uploaded online Part-I is not found signed by you. A copy duly signed by you is required to be uploaded.
- 3. Justification report uploaded online Part-I is not found signed by you, also the uploaded copy is different with the copy placed in proposal folder. A copy duly signed by you is required to be uploaded.
- 4. Alternatives maps uploaded online Part-I is not found signed by you. A copy duly signed by you is required to be uploaded.
- 5. Employment likely to be generated is mentioned 3050 man days online Part-I, whereas in the hard copy of Part-I it is mentioned 28715 man days and at Check list-4, 36150 man days. Please clarify and correct it.
- 6. Cost benefit Analysis is found uploaded online Part-I, but also the same is not found placed in the proposal folder. Required to be attached in the proposal folder.
- 7. As this proposal is under Violation, but Panel NPV is not found placed in the proposal folder¹ or found uploaded in the online portal, which is required. Also,

the copy of violation report is required to be uploaded against the additional information of Part-II.

In the reclamation Plan, the (Engineering measures) estimate for providing the crate to the proposed dumping site is found but plantation scheme/cost of reclaim the same is not found attached. Please check and provide the same.

- In the Check List -7 and village wise details given online at Column No. B 2.4 a village name is found mentioned **Satrunda**, but as per the proceedings of the FRA certificate and few Revenue Papers it is mentioned **Sarunda**. Please check, clarify and correct it.
- The maximum documents uploaded online part-I is found without you signatures.
 The copy duly signed by you is required to be uploaded.
- 11. As per the hard copy Part-II, the legal status of forest land is mentioned DPF and falls shown under Category of 1952 Notification. But, as per the online, whole the area is mentioned as Protected Forests. This also required to be corrected.

Hence, you are requested to please attend the above observations and re-submit the case to this office at the earliest, so that the further action could be taken under FCA-1980. All the proposal folders (3 Nos) as received in this office vide your office memo under reference are returned herewith to do the needful.
