Submission of revised proposal seeking prior approval of Central Government under the Forest (Conservation) Act, 1980 for diversion of 87.520 ha of forest Land construction of Hidsingh irrigation Project including Alternate Road in Angul Forest Division under Angul District.

With reference to the above cited correspondence on the subject, it is to inform that on scrutiny of the Diversion Proposal, the following observations by Principal Chief Conservator of Forests, Forest Diversion & Nodal Officer, F.C. Act O/o the Principal CCF, Odisha for compliance.

- 1 The project approval Order of the Water Resources Department, Govt. of Odisha has not enclosed in the DP.
- 2 The copies of Gram Sabha resolution along with SDLC proceedings of FRA-2006 pertaining to forest land involved in this project is wanting.
- 3 As per MoEF & CC, GoI guidelines dated 28.03.2019. FRA certificate is to be submitted in prescribed format II & III.
- 4 It has been proposed to take up ANR with 200 seedlings over 94.216 of non-forest Govt. land identified in village Tanugula, Kadambinipur & Baradiha under Pallahara Tahasil of Pallahara Range under Deogarh Forest Division, but verifying the KML & Shape file enclosed with DP of the proposed CA land this DSS. It is found that 53 ha out of proposed 94.216 ha is VDF & MDF. So the DFO, Deogarh may be instructed to address the issue including of the CA scheme appended.
- 5 The CA scheme along with CATP needs to be revised at the current wage rate of Rs.311/- per mandays.
- 6 The approved R&R Plan has not been included in the DP.
- 7 The alternative for the reservoir has not been provided in the DP.
- 8 The non-forest CA land show in photo copy of the Topo sheet No.73G/2 is not clear and also not countersigned by the DFO, Deogarh.

- 9 The GPS reading of the starting point and end point of the Right main canal, Left main canal and alternative road have not been furnished in the DP.
- 10 The DFO, Angul has proposed Bald hill plantation cost norm for Soil and Water Conservation measures in CATP. So, the DFO, Angul to be furnished an certificate that the CATP site is above 30 percentage.


In view of the above, the compliance and the proposals is returned herewith through EDS for taking further action at this end.
