Please refer to the State Govt letter on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980, I am directed to inform that the proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980 and rules/guidelines framed thereunder and observed that the present proposal of 5.40 ha is a recast of the earlier proposal i.e., "the proposal for diversion of 5.38 ha of forest land for operation of Gopeswar Stone quarry & mining zone area under North Kamrup Division in favour of Sri Fatik Das, Guwahati(F. No 3-AS C 011/2019-SHI)" which has not been withdrawn by the State Govt. After proper scrutiny it was also seen that the State Govt has applied with the same online number No. FP/AS/Qry/37021/2018 which was not mentioned in any of documents or in the State Govt letter, which is misleading.

State Govt is requested to either withdraw the previous proposal or stick to the old one with reply towards this office letter under reference (ii) & (iii) above (Copy enclosed) to be furnished to this offices, for further processing of this proposal.
