With reference to above mentioned subject, I am directed to request that in reference to the Ministry letter No. 8-05/2024-FC dated 20.03.2024 wherein the State Govt. was requested to upload the correct KML file of 0.28 ha proposed forest land. In this reference the State Govt. vide their letter dated 23.07.2024 has submitted the information and on analysis of said KML file in the Ministry it has been again observed that still the KML file of the proposed forest land is found 0.764 ha instead of 0.28 ha.
