महोदय.

उपरोक्त विषय पर सन्दर्भित पत्र का आशय ग्रहण करते हुए प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित किमयां पाई गयी है। अतः राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें। ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:—

- 1. Name of proposal not mentioned in authority letter and details of signatory not found. State Government may submit the authority letter mentioning the name of the proposal as well as providing the detail of signatory.
- 2. On perusal of KML file of the proposed road, it is seen that, starting point of road is not clear and location of benefitted villages not marked. Further, alignment of road beyond point 35 as per digital map does not seem required. State Government may submit the KML file of the proposed road showing starting and end points of the road clearly and location of the beneficiary villages may also be marked.
- 3. Benefitted village's code are not mentioned in village to be benefitted certificate. State Government may mention the code of village in the certificate of village likely to be benefitted.
- 4. FRA uploaded online is not original and clear. State Government may upload clear and original copy of the FRA certificate at para K Part I online.
- 5. Administrative approval found uploaded is for some other proposal. State Government may upload administrative approval for the proposal mentioned in the subject.

- 6. Land schedule found incomplete. State Government may submit/upload the complete original hard copy of the land schedule duly countersigned by the concerned DFO.
- 7. In the tree enumeration list, trees from 0-20 dia class are shown together. State Government may submit tree enumeration list of 0-10 and 10-20 dia class trees separately.
- 8. State Government may submit/upload the detailed muck disposal plan along with photograph.
- 9. It seems that the user agency now is WAPCOS. State Government may submit clarification in this regard and if so, revise the details online and submit proposal in accordance with rules or change in UA.
- 10. No comments have been made by DFO at para 6 in Part II. State Government may ensure that the comments of DFO is provided against para 6, Part II.
- 11. No comments have been made by DFO at para 5.3 and 5.5 (b). State Government may ensure that the comments of DFO is provided against para 5.3 and 5.5 (b), Part II.
- 12. Joint Inspection Report found uploaded is place of DFO's recommendation at para 16 Part II. State Government may upload the recommendation of DFO at para 16, Part II online.
- 13. State Government may submit the hard copy of the proposal containing original documents.
