With reference to the subject and letter cited above, I am to inform that State Govt letter under reference above has been examined by the REC in its meeting held on 29.06.2022. The REC seriously noted on the request of the State Govt for revising the proposed area from 2.28 ha to 2.22 ha as this instant proposal for 2.28 ha was discussed and recommended by the REC on 09.10.2018 in Regional Office, Shillong. The REC requested the State Govt and user agency not to repeat such mistakes and submit the proposal only after meticulously examining the details of the proposed area. The State Govt is requested to take necessary action on the following as decided by REC and inform this IRO, Guwahati for further necessary action:-

(i) To upload the revised documents Part I, II, III, IV & V Form along with SoI maps, undertaking for CA, NPV, shape/kml file, etc of the revised proposed area i.e. 2.22 ha and CA site, etc on parivesh portal in consultation with NIC, MoEF&CC, New Delhi.

Further State Govt is requested to submit the proposal to this Ministry only after thoroughly checking all the relevant documents, maps, kml file etc, in future to avoid wasting time of the REC members and so as to enable to process the proposals without delay.
