
महोदय,

उपरोक्त सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरांत निम्नलिखित कमियाँ पाई गयी हैं:

- 1- Though the State Govt. clarified that the transmission will be carried out through underground cable but requires proper evacuation plan duly authenticated by competent authority.
- 2- As per existing guideline the RoW upto 33 KV is fixed for double circuit line is 1.2 m but in this case it is taken as 4 m which needs to be clarified by the State Govt.
- 3- The NoC for village 'Kumsu' and 'Duttnagar' is still not provided by the State Govt. Hence, State Govt. may submit the NoCs of villages 'Kumsu' and 'Duttnagar' in original to this office.
- 4- In the DSS analysis, it is found that CA area Patch- 1 of the proposal is already been submitted with online Proposal no. FP/HP/Road/11990/2015 and CA area Patch 3 of the proposal is entirely overlapping with online proposal no. FP/HP/Road/ 21461/2016 and FP/HP/Others/10023/2015 which may be reviewed by the state govt. and replace this area with some other suitable area for CA and ensure that no MDF/VDF found in the area proposed for CA.
- 5- State Govt. may also clarify that why all dumping sites can not be shifted to non-forest area and should try to locate non-forest area for dumping.
- 6- State Govt. may submit the reasons for delayed as per guideline para 1.20.
