In inviting a reference to the aforesaid office memo on the subject, this is to inform you that the compliance submitted by you on the observation pointed out in respect of **point No. (b)** as sought for by Dy. Inspector of Gneral Forests (C), GoI, MoEF & CC, RO, Bhubaneswar is not proper. Hence, I am directed to request you to furnish proper compliance on the observation of GoI, MoEF & CC, RO, Bhubaneswar. Besides, the followings may also be complied.

1. The RoR of the non-Forest Govt. land over 1.216 ha which has been mutated in favour of the Forest Department may be provided,
2. It is reflected in the CA scheme that 0.998 ha of area out of 1.216 ha is fit for plantation but no plantation has been proposed except fencing, in the CA scheme. Please justify the same.
3. The CA scheme for additional CA land over 1.216 ha which has been identified in degraded forest land in Jamubani-Patharbani RF of Khandapada Range may be rectified. It must contain SoI Topo sheet, GPS Map, suitability certificate, DSS analysis certificate etc.

The above information/compliance be submitted at the earliest.
