Diversion of 3.9705 hectare of forest land in favour of HPPWD for the construction of link road from Padyalag, Dohru, Maryani, Chandoh, Dadhol Kalan, Patta, Dikhut (Km 0/0 to 6/450), within the jurisdiction of Bilaspur Forest Division, District Bilaspur, H.P.

नोडल अधिकारी-सह-एपीसीसीएफ (एफसीए) पत्र क्रमांक. 48-3027/2022 (एफसीए) दिनांक 09.05.2023.

महोदया/महोदय,

उपरोक्त विषय पर संदर्भित पत्र का आशय ग्रहण करते हुए आपको यह सूचित करना है कि प्रस्ताव में निम्नलिखित कमियां पाई गई हैं। अतः राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचनाएं प्रेषित करने का कष्ट करें, ताकि आगामी कार्यवाही की जा सके:-

1. In reply to SN. 1- **REPLY NOT ACCEPTED.** State Government may furnish the details of violators for further necessary action as the proposal. Since as per the latest direction of the Ministry of Environment, Forest and Climate Change, Government of India vide File No. FC-7/43/2020-FC dated 22.03.2022, the proposals for use of forestland for non-forest purposes which includes violation of the Forest (Conservation) Act, 1980 as specified in Para-1.21 (i) and (ii) will be examined at the level of Ministry after discussion in REC.
2. In reply to SN. 3-**REPLY NOT ACCEPTED.** In Part-1, A -3 (xvii), the name mentioned in the authorization letter does not match with the details of the person making the application to ensure the completeness of the proposal. Either clarification for the mismatch or fresh authorization certificate needs to be submitted.
3. In reply to SN.11, SN.16, SN.17 and, SN.18 - **REPLY NOT ACCEPTED.** A complete Enumeration list including the compartment no along with date of tree enumeration which is duly authenticated by the concerned DFO, needs to be provided to gain the clarity on the above mentioned points.
4. In reply to SN. 19- **REPLY NOT ACCEPTED.** As per para 2.4 (vii) of the Handbook of FCA, 1980 and FC Rules, 2003 (Guidelines and Clarifications), MoEF&CC, 2019, State Govt. may look for a new CA site (i.e., Open Forest) along with the Status of Proposed CA land may be provided, whether it is a Govt. Wasteland is declared as PF under HP Govt. notification, 1952, or it is notified as UPF/DPF under IFA 1927. Additionally, submit documentation regarding the suitability of land for CA in lieu of forest land proposed for diversion in terms of its vicinity to the area being proposed for DA and/or contiguity with the existing forest area and also ensure the manageability as per the latest Guidelines of MoEF & CCvide letter No. 11-423/2011-FC dated 13.07.2022.
