Please find enclosed herewith a copy of the Ministry's communication referring to Government of Maharashtra's proposal, and subsequent clarifications, seeking *ex-post facto* approval under Section 2(1)(ii) of the Van ( Sanrakshan Eevam Samvardhan) Adhiniyam, 1980.

The matter was considered in the Advisory Committee meeting held on 25.08.2025. The Committee, after examination, has deferred the proposal and sought certain clarifications / information from the State Government. The relevant portion of the communication is reproduced below for necessary action:

1. As per the DSS analysis based on the KML file received from the State, the total area under the Transmission Line (TL) is found to be 95.218 ha., of which 1.21 ha falls within forest area. However, the proposal submitted is for diversion of only 0.45 ha of forest land. The State Government shall ensure that the entire forest land involved in the Transmission Line is included in the diversion proposal, and the revised proposal be submitted along with relevant documents and updated KML files.

In view of the above, you are requested to take necessary action in the matter and submit the compliance of above query at the earliest submission to the Government of India.
