Sub:- Proposal for diversion of 0.687 ha of Revenue Forest Land (Bada Jungle) located in village Belpahar of Lakhanpur Tahsil under Jharsuguda Forest Division for construction of 132 KV Budhipadar-Jorabag transmission line from Loc 70-74 in favour of OPTCL, Jharsuguda due to crossing of MGR Rly line .(Proposal No: FP/OR/TRANS/42979/ 2019 with State Sl. No :- OR /078/2019 dtd 05.12.2019)

Ref: Memo No.1349 dated 21.07.2020 of RCCF, Sambalpur Circle.

In inviting a reference to your memo cited above on the captioned subject, this is to inform you that, on scrutiny of the diversion proposal submitted by you, the following deficiencies are noticed.

- (i) KML & Shape file of the proposed Revenue forest land under Jharsuguda Forest Division to be diverted have not been furnished in the DP.
- (ii) Actual number of trees to be felled and to be pruned out of total 40 enumerated trees over the proposed project area is to be furnished.
- (iii) In the project details it has been mentioned by UA that this project involves total area of 1.754 ha. Out of 1.754 ha , 1.026 ha is common to both existing line and proposed new power line. Further the UA reports that this 1.026 ha of land has been diverted for Budhipadar-Jorabag 132 KV DC transmission line earlier for which Stage-II approval has been accorded. Hence to ensure the actual land already diverted and common to both the proposed project & earlier project, the detailed land schedule of both Forest & Non-Forest land involved in Budhipadar-Jorabag 132 KV DC transmission line indicating the plots common for the both the projects may be furnished. Further, the hal & sabik kisam of the non-forests common plots may be furnished with due authentication.
- (iv) The length of proposed transmission line over forest land & in Non-forest land for the project both excluding & including the common corridor be furnished separately.
