महोदय.

उपरोक्त विषय पर सन्दर्भित पत्र का आशय ग्रहण करते हुए प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, तािक अग्रिम कार्यवाही सुनिश्चित की जा सके:—

- 1. It is seen that the details of non forest land not filled online. State Government may fill the details of non-forest land online at designated places.
- 2. In the geo referenced digital map of the area proposed for diversion uploaded at C (iv) Part I online, geo coordinates are shown at very few points. State Govt. may provide/upload scanned copy of GIS software generated geo referenced digital map to the exact scale of the proposed road showing geo coordinates at 200 to 300 m interval along the alignment including all turning points.
- 3. Cost benefit analysis not found uploaded. State Govt. may upload the Cost benefit analysis as per prescribed format quantifying all parameters in monetary terms.
- 4. As per DSS analysis, 3.14 ha area of proposed CA land is found overlapped with proposal no. FP/UK/ROAD/16367/2015. State Government may submit clarification and do the needful in this regard.
- 5. CA scheme of single page of Rs. 51,70,253/- is found uploaded. State Government may upload the detailed CA scheme as per current rate.
- 6. Details of 372 trees submitted in the tree enumeration list excluding trees falling in 0-30 cm. However, details of 562 trees mentioned at para 4 in part II in which 319 are in girth-class of 0-30 cm and 243 trees in above 30 cm. State Government may clarify the disparity and submit/upload correct detail.

- 7. Eco class mentioned at para 4 online part II as Eco class I but in NPV sheet it is mentioned as Eco class III. State Government may clarify the disparity and submit/upload correct detail.
- 8. Aerial distance certificate not found uploaded. State Government may upload the aerial distance certificate.
- 9. DFO mentioned at para 8 in part II that area is part of Shivalik elephant reserve. State Government may submit the comments of CWLW.
- 10. Nodal Officer in his recommendation mentioned that area is not part of national park/sanctuary/reserve. The comments of Nodal regarding point no. 09 above are required to be submitted.
- 11. State Government may submit the report of DFO examining the adverse impact studied by WII, if any.
- 12. DFO mentioned at para 6 that area is prone to erosion as located near Gaula river. State Government may submit the protective measure in this view.
- 13. DFO has made no comment in his SIR at para 5.3 and 5.5 (b). State Government may submit the Site Inspection Report after ensuring that the comments against each para 5.3 and 5.5 (b) have been made.
